
At the beginning of this school year, we reduced noon hour supervision fees from \$110 to \$75 for grades 1-6 students (\$37.50 for Kindergarten). This program runs at cost. This fee provides sufficient supervision for the number of students who stay for lunch. This is \$7.50 per month for grade 1-6 students and \$3.75 per month for Kindergarten students. We hire individuals to supervise students outside during recess as well as while they eat. Each individual supervises 2-3 classes while they are eating. Educational Assistants also help out with supervision. Please share any thoughts regarding noon hour supervision.

- There shouldn't be a cost. If should be teachers who take turns. However, as it's a highered position now I guess I agree with the lower fee. \$110 is ridiculous





Kindergarten to Grade 5 students take one session of swimming lessons at a cost of \$65 per student. Do we continue to offer this optional program at DCE?




- I would rather do swimming lessons separately with my child, not through school.



Grade 4 - 6 students go skiing once a year. This activity costs up to \$45 per student. Do we continue to offer this optional program at DCE?




