School Trustee Report – Trina Boymook



- At January 25 Board meeting the Board approved a solution to address the anticipated enrolment pressures in Ardrossan, enhance French Immersion program retention and balance senior high enrolment in Sherwood Park:
 - Relocate EIPS' senior high French Immersion program, grades 10-12, to Salisbury Composite High—effective when the new Sherwood Park replacement school opens, expected in the 2026-27 school year;
 - adjust Strathcona County's senior high attendance boundaries for Lakeland Ridge to be redesignated to Bev Facey Community High—effective when the new Sherwood Park replacement school opens, expected in the 2026-27 school year; and
 - adjust the French Immersion junior high attendance boundaries for Cambrian Crossing, to be redesignated to Sherwood Heights Junior High—effective in the 2024-25 school year.

Senior administration will begin working a transition plans. Parent engagement will take place to inform the development of this plan.

- The Board approved to spend up to \$5000 to cover ASCA Conference and AGM registration for interested school council members who are members of ASCA. This opportunity is limited to only one per school council.
- The Board approved the 2024-25 School Fee parameters. Parameters allow for a maximum of 5% increase, with 7% for food courses. Anything above will require special approval by the Superintendent's office.
- The Board Chair attended a meeting on the draft Social Studies curriculum. At this meeting they shared the scope and sequence. Without the details, it is difficult to determine in what ways it has been adjusted and where concerns may lie. We continue to monitor the curriculum develop work closely.
- Boards and senior administrators were invited to a meeting with the Education Minister on the recent Premier announcement on future legislation on pronouns and transgender youth. The minister intends to engage Boards in conversations to inform legislation and policy development. The Board is currently developing a letter to the minister to express our concerns on the safety of students, share our lived experience, the importance of engaging school boards for the interest of student safety and our interest to participate in future discussion.
- The Board has introduced a "Did You Know?" series to highlight those things we think
 parents might want to know. This month's message was "Section 58.1 of the current
 Education Act, already requires school boards to notify parents and caregivers when
 courses, programs of study, instructional materials, and instruction or exercises contain
 subject matter that deals primarily with human sexuality. Included in this notice is always
 and opportunity for parents and caregivers to opt out of instruction without academic
 penalty to the student. It's a practice that has been in place since 2014 and one that EIPS
 has consistently followed." There seems to be a misconception in the community that this
 sensitive topic is being covered without parents knowledge. If you ever want to learn more



about what is covered and the materials used please speak to your classroom teacher or principal.

Wellness Committee Update- Candice Abraham (absent)

We'll be looking for parents to come in 2x/week for the first three weeks and then go down to 1x/week for the next 4 weeks and then after that continue the program for another 4-8 weeks. More information will be available in March.

EIPS Board Chair Cathy Allen presented the Board Report, detailing many Board of Trustees activities in January and the beginning of February. There was a discussion relating to how COSC members should go about advocating to the provincial government. Board Chair Allen said parents and caregivers can consider sending advocacy letters to:

COSC Chair Kendra Roemer added that families can also refer to the <u>Alberta School</u> <u>Councils' Association (ASCA) Advocacy Package</u> on how to advocate for education.

COSC SHARING: School councils' past ASCA conference experiences

COSC members shared their past experiences at the ASCA Conference and AGM, detailing how they gained valuable information, networked with councils from across the province, and saw their own school and EIPS from a new perspective. Jacquie Surgenor attended the event last year and presented on the Reset Room initiative—a mental health project piloted at all EIPS junior highs. Surgenor discussed the initiative from her perspective as a parent at Sherwood Heights Junior High, emphasizing the collaboration between the school and families. Additionally, COSC Chair Roemer noted Wendy Keiver, the Executive Director at ASCA, will be joining the meeting next month to speak on the ASCA resolutions for the AGM. She'll also be there to answer questions about ASCA generally.

ASSURANCE CYCLE: EIPS Budget survey, Alberta Education Assurance survey and EIPS Annual Feedback surveys

EIPS Superintendent Stoddard and Associate Superintendent Marshall discussed several surveys:

- EIPS Budget survey—completed in December 2023 by staff, families, Grade 12 students and community partners.
 - Superintendent Stoddard said the number of responses significantly increased across all stakeholder groups.
- Alberta Education Assurance Survey—to be completed by parents and guardians of students in grades 4, 7 and 10. Teachers and students also complete the survey online at school.
 - In schools with fewer than 120 students in grades 4-12 and most charter and private schools, surveys are sent to parents and guardians of students in Grade 4 and above. The deadline to complete the survey is **March 1**.
- EIPS Annual Feedback Surveys—to be completed in March by staff, families, and Grade 9 and 12 students.
 - As the feedback surveys are still being drafted, school councils will receive a copy of the survey questions in the March COSC meeting package.

Principal Report – Helene Hewitt

2024-25 School Fees Parent Feedback:

- 53 people responded less than last year but still great to get feedback
- One lucky parent who has 3 students at our school won the Sobeys gift card through a random draw.

General demographic data:

• 53% of respondents will have 1 child at DCE next year



- 40% of respondents will have 2 children at DCE next year
- 28% of respondents have kindergarten children
- 55% of respondents have children in Grades 1 to 3
- 53% with kids in Gr. 4-6
- Most comments said that fees seemed fair and reasonable

Lunch supervision fee themes:

- 93% of respondents supported raising the fee to avoid a deficit
- 4% or respondents did not support the increase
- Majority of comments expressed appreciation for our noon supervisors
- Other comments wondered about who should be responsible for providing lunch supervision while others suggested that they would be happy to increase the number of supervisors.

Field Trip Fees themes:

- # of field trips:
 - 41% want 3 or 4
 - 32% want as many as possible
 - 13% want one or two
- Cost per field trip:
 - 43% want \$30 or more
 - 36% want \$20 per trip
 - 8% want \$15 per trip
- Comments included liking field trips and their importance to learning/fun, desire for more trips and the wondering if they always have to be educational or could they be more of a fun experience

Swimming themes:

- 93% would like to continue with swimming and find it valuable
- A few people wondered if Gr. 4-6 could also have lessons
- Parents and Principal discussed reasons for permanent change and parent members in attendance agreed.

Our plan going forward:

- Request a 10% increase for noon supervision to offset potential deficit
- Add a track competition fee
- Increase swimming lessons to \$75 to cover increase in busing
