1. Called to order at 7:48 PM
2. Minutes from March meeting approved by Kari, seconded by Hannah
3. Math-a-thon Update
 - a. \$13,470 raised
 - i. Mrs Dreschels class was top for fundraising dollars for Div 1
 - ii. Mrs Shoplands class was the top for fundraising dollars for Div 2
 - iii. Mrs Breens class was top for most improvement for Div 1
 - iv. Mr Millers class was the top for most improvement for Div 2
4. Bottle Drive Update

- a. \$414.40 was raised from the bottle drive during the dance April 4
5. Dance Concession Update
- a. \$1560 raised from the concession for the dance April 4
 - i. Cotton candy was a popular item
6. Big box fundraiser
- a. Sample cards and forms will go out this week, orders need to be into the school by May 1st.
 - b. Boxes of cards are \$35 each, candles are \$40. \$11 from each box goes to the school. Prizes are awarded depending on how many boxes are sold.
7. Financial Report
- a. With the success of the math-a-thon and the dance concession, 2 items that were previously removed from the budget were brought back to the table as funds are now available.
 - i. \$1500 for gym equipment
 - ii. \$1000 for watermelon/oranges/healthy snack for the wellness committee to use
 - iii. A freezie/popsicle day for the school was discussed as well, with \$200 proposed. Possibly to be used for track and field day
 - b. Motion made by Robyn Beck to approve funds for the above 3 items, voted in unanimously by 6 executive and directors in attendance
 - c. Jugo juice makes freezie smoothies that were also considered. A cost will be acquired prior to assessing if it is a possibility
8. Casino Funds vote
- a. \$16,835.89 currently remain in the Casino account
 - b. A request for funds has been made by the school
 - i. \$6000 for Physical Education equipment
 - ii. \$8000 for Chromebooks
 - iii. \$1100 for a school mascot
 - c. Motion made by Robyn Beck to approve funds for the above 3 items from the Casino account, voted in favor by the 6 executive and directors in attendance.
 - d. There may be leftover monies after payout of this request. A wishlist was discussed for possible ideas for the remainder of the balance
 - i. Bike racks

- ii. Benches for the park. This may need to go through the county rather than be funded from this account
- iii. Bringing in an author for literacy night
- iv. Hosting a session on internet safety. Julia the mental health person at the school is already looking in to this
- v. Possibly a custom jersey for the school mascot
